It is the policy of the Nebraska Environmental Health Association that every effort shall be made to identify and reward deserving environmental health professionals through special recognition by their peers.

This award is available on an annual basis for presentation to an outstanding Environmental Health Specialist who has, during the year prior to selection, made a major impact on the field of environmental health by the development of a special program, educational activities, involvement in the legislative process, or any special achievement which enhances the delivery of environmental health services.

Environmental Health Professional of the Year Award eligibility requirements: Any person in the field of environmental health who currently holds a REHS, a member in good standing with NEHA and practiced in Nebraska during the previous year. Activities must have occurred in the previous year (October 1 to October).

**INSTRUCTIONS FOR NOMINATOR:**

Use the scoring criteria to prepare your nomination submission. Multiple nominations are welcome. Your completed nomination must be postmarked no later than **September 30<sup>th</sup>**.

You will receive confirmation when your nomination has been received. The selected recipient will be announced at the annual conference.

**NOMINATION REQUIREMENTS:**

1. Nominations shall come from a NEHA member in good standing.
2. Please attach all possible documentation to demonstrate the accomplishments of the nominee which have enhanced the field of environmental health during the past year. <b>1. Innovation</b> – New to division or State/Special project, Educational activities. *Credit will be given for developing innovative approaches that deal with technical, managerial and/or administrative issues.	5		
<b>2. Duration of Impact of Project</b> - <1 Month to 1 Year. Credit will be given for length of program or activity. *Credit will only be given for activities occurring in year of award nomination	5		
<b>3. Scope of Impact</b> - Local or Statewide. Credit will be given for scope of program or activity. The more extensive the scope of impact the higher the assigned value.	5		
<b>4. Collaboration</b> - Intradepartmental-Multi-organizational. Credit will be given for collaborative efforts in programs/activities.	5
